# 1. Apologies for absence

### 4. Acquisitions

The Committee noted the acquisitions made since12 March 2009.

The Committee reviewed and discussed a number of possible acquisitions. The following works of art were approved for acquisition:

Frank Bowling (born 1936) **Kaieteurtoo** (from the series Poured paintings), 1975 Acrylic on canvas 184.4 x 105.4 cm £20,000 discounted to £17,500 inclusive of VAT Rollo Contemporary Art, London

Mary Martin (born 1951) **White Diagonal** 1963 Stainless steel, formica and wood 60 x 60 x 10.4 cm £28,000 discounted to £22,000 inclusive of VAT Annely Juda, London

The Director was asked to negotiate a further discount or enhanced purchase for Nelson's Ship in a Bottle 2009 by Yinka Shonibare. Two sets of Paul Graham photographs were once again considered and a decision on them postponed until the Committee had had a chance to see them.

# 5. British Embassy projects (verbal update)

Warsaw – The Director outlined progress to date and her discussions with the architect. She noted that a contemporary abstract work was now being sought for display in the Entrance Hall.

Algiers – The Director outlined progress on finding a work for the Embassy.

Jakarta – The Director noted that the FCO had reported that the previous design had been cancelled.

### 6. Government Art Collection exhibition at Whitechapel Gallery

The Director noted that the Whitechapel Gallery had agreed to stage an exhibition on the GAC in 2011/12. It is to be in four stages and expected to tour a number of regional galleries. Initial discussions on content and format were about to take place.
