1. Apologies for absence

Apologies were received from Andrew Renton.

2. Minutes of the last Committee meeting held on 17 July 2014

The minutes of the last meeting were agreed and signed by the Chairman.

3. Matters arising

3.1 Work under consideration for new co-location of FCO and British Council, Shanghai Further options for art are being explored.

3.2 Portrait of Queen Victoria by Sir David Wilkie

Sandy Nairne and Penelope Curtis asked if the work could be conserved locally. The conservator who recently saw the work suggested not.

4. Update on fund-raising options for the GAC's acquisitions

The Director noted that the Contemporary Art Society and Outset provided the two most promising options. Iwona Blazwick thought there would be options through London Open, Jerwood Prize and John Moores. The Committee agreed this was a good option and would avoid the GAC having to go to the market. The Director asked if anyone knew of any artist's estate that could be approached for a donation.

The Director explained that the DCMS Project Team were looking at how alternative funding and structures might be introduced to the GAC. The Chairman suggested that the GAC may need to restructure to take advantage of alternative options.
