Summary of the minutes of the meeting held on Thursday 19 March 2015 at the Government Art Collection

1. Apologies for absence/welcome new members

Apologies were received from David A Bailey, Iwona Blazwick and Clare Pillman. The Chairman gave a warm welcome to the two new members of the Committee, Susan Collins and Clare Lilley.

2. Minutes of the last Committee meeting held on 13 November 2014

The minutes were agreed and signed by the Chairman.

3. Matters arising

3.1 Portrait of Queen Victoria by Sir David Wilkie

The GAC has contacted the Hamilton-Kerr Institute, who have worked on a conservation project in Kolkata, for advice.

3.2 Acquisition and Disposal policy

The policy had been amended in response to the Committee's comments and had been agreed by the Permanent Secretary of DCMS.

4. Update on fundraising options for the GAC's acquisitions

The Director informed the Committee that the Minister requested more work be done on the proposals and another member of the Project team had been allocated the task.

The Committee discussed the issues surrounding the formation and management of a patron's group. Based on their experience members noted that a small team like the GAC was unlikely to have the resources or skills to set-up and manage such a group. Their own organisations had dedicated teams working full time in what was challenging terrain with a small number of sponsors being courted by many organisations.
