3.3 Approaches made to GAC for consideration

No acquisition was recommended.

### 4. Update on Portrait of Queen Victoria, New Delhi

The Director brought the Committee up to date on progress in finding a suitable display location. Two potential venues in Mumbai have been identified. They both have a connection with the original owner of the portrait, a businessman and philanthropist Sir Jamsetjee Jejeebhoy a descendant of whom gave the painting to the Deputy High Commission (DHC) in 1980. The GAC will take the opportunity to explore these possibilities with the help of the current DHC, when in Mumbai in the autumn.

### 5. Government Art Collection - verbal update

Outset/Government Art Collection Fund

The GAC continues to work with Outset to bring new works into the Collection. Discussions are underway with Laure Prouvost to identify one of her works and with Richard Wentworth to finalise the display of one of his works.

Old Admiralty Building (OAB)

There are a number of design elements that remain unresolved, in particular within the gallery space. The GAC has sought specialist architectural advice to help with this. It is anticipated that the likely occupation date will be 2018.

### 6. Director's Report of GAC activities since 17 March 2016

The report was noted by the Committee.

### **7. AOB**

Iwona Blazwick suggested that an acquisition prize might be considered for the GAC and would help regional artists. Potential partners are John Moores, Bloomberg/New Contemporary and Northern Art Prize. She also noted the success and lasting impact of the GAC's Cornelia Parker curated show in 2011/12 at the Whitechapel *Richard Of York Gave Battle In Vain*. She asked whether it might be possible

for GAC to have touring exhibitions perhaps in tandem with the South Bank. The Director said that further GAC exhibitions were under consideration: one exhibition, curated by the GAC's Nicky Hodge, is being planned in Hull during the city's tenure as UK City of Culture in 2017.

David Bailey commended the Goldsmith's Postgraduate Curating Course students' display *Embassy Hack* at the GAC.
