1. Apologies for absence

Apologies were received from Iwona Blazwick and Nicholas Cullinan.

2. Minutes of the last Committee meeting held on 17 November 2016

The GAC Director reported the following:

- She had negotiated a 15% discount on a painting viewed at the last meeting.
- The British Embassy in Iran have agreed to Andrew Parratt's recommendations discussed in November's meeting, and the Ambassador will visit the GAC in June

4.4 Bloomberg New Contemporaries 2017

The Director explained a new initiative for an annual GAC prize purchase from Bloomberg New Contemporaries (BNC) – a first for both organisations. The Director said that the GAC would ring-fence £5,000 in 2017 for a BNC purchase but may not necessarily spend the amount. The Director invited any committee members to view the selected BNC 2017 works in April.

4.5 Proposed work for the exhibition An Eyeful of Wry

The Committee approved of a proposed Peter Liversidge commission for An Eyeful of Wry noting the artist's strong element of humour and its potential to reach out to different communities and a more youthful demographic. The Committee also discussed whether the fee represented good value with the majority carrying the vote. It was also agreed that the artist's book of proposals should be named Proposals for the Government Art Collection. The Director outlined a timescale of receiving artist's proposals by July for completion in time for the exhibition in Hull in autumn 2017.

5. Update on portrait of Queen Victoria, New Delhi

The Committee noted the actions taken since the previous meeting and approved the next steps, which are contingent on formal agreement of loan by the Dr Bhau Daji Lad Museum, Mumbai.

6. Government Art Collection - verbal update

The Director reported the following:

- Recent press articles had overstated the size of the planned Public Display Space at the GAC's new
 accommodation at Old Admiralty Building. The Committee's discussion noted that although the
 space would be a single room, it would be the first time the GAC could offer public access without
 having to book.
- The Government's recently published Industrial Green strategy has recommended that the GAC

be involved with the Midlands Engine strategy and seek opportunities to work with collections in Birmingham and environs. The Committee discussed the Hull commission and exhibition as a potential model for future activity in the Midlands.

7. Director's report of GAC activities since 17 November 2016

The Committee noted the report.

8. AOB

- Alex Farquharson and David A. Bailey reported they had visited Winston Branch's studio, but did not see a suitable work for the GAC to acquire.
- The Chair and Director reported that Edmund de Waal had offered a choice of two pieces for longterm loan (five years) to the British Ambassador's Residence in Vienna, and that a visit would need to be made to establish which one could be installed in the building. The Committee agreed to proceed with the loan.
- Adrian George gave a summary of the AHRC-funded post-doctoral research post for which the GAC
 is involved in partnership with the University of York, who is making an application to the AHRC. This
 would be for three years looking at GAC influence on cultural diplomacy in several diplomatic posts.
 The application will be submitted at the end of March.
- The Director thanked Andrew Renton and David A. Bailey for their time on the Advisory Committee
 on the GAC. They both commented that it would be important for diversity to be retained with the
 appointment of new members.
