1. Apologies for absence

Apologies were received from Iwona Blazwick, Susan Collins, Alex Farquharson and Clare Lilley.

- Gabriele Finaldi commended the work of the GAC in securing the loan of the Edmund de Waal
 work for the British Ambassador's residence in Vienna. The GAC Director said this had been an
 interesting project and the GAC would consider other potential relevant loans from artists, subject to
 the amount of administration required.
- The GAC Director mentioned that the Collection does not include any paintings by David Hockney
 and it would therefore be appreciated if Committee members could assist in any way to help secure
 an acquisition.

4.3 Bloomberg New Contemporaries 2017

The Director informed the Committee that she and Andrew Renton had viewed works selected for the 2017 Bloomberg New Contemporaries (BNC) exhibition in April with a view to purchasing one or more for the Collection. The Committee were shown images of the works that had been identified. It was agreed the images would be forwarded to all members after the meeting and each member would give their feedback. The Director explained that the next stage will be for the GAC to let the BNC know which works they wish to continue to consider and to see the BNC 2017 exhibition at BALTIC and BALTIC 39 on 28 September. At that point the acquisition of the work(s) will be confirmed and the BNC and GAC plan to announce this, subject to DCMS press communications strategy.
