1. Apologies for absence

3. Matters arising

- The GAC Director updated the Committee on the portrait of Queen Victoria. During a trip to India in February/March 2018, the GAC Director visited INTACH conservation studio in New Delhi to help move the project forward. A formal agreement from Dr. Bhau Dhaji Lad Museum is now being sought. The conservation programme is still planned for 2018.

4. Acquisitions

4.1 Proposal to purchase work by women artists in FY 2018-19

The Committee was invited to consider the proposal to restrict purchases to works by women artists during the financial year 2018-19 to commemorate the centenary of the Representation of the People's Act. The GAC has been strengthening the representation of women artists in the Collection and the current centenary is an appropriate moment to make a significant push in this regard.

Whilst only works by women artists will be bought by the GAC, gifts and works via the Outset/GAC Fund by male artists would continue to be acquired if appropriate.

After discussion the proposal was agreed by the Committee.

4.3.3 Bloomberg New Contemporaries 2018

Curators of Information and Research (Modern & Contemporary), Chantal Condron and Jessica Cerasi, viewed works selected for the 2018 Bloomberg New Contemporaries (BNC) exhibition on 6 March with a view to the GAC purchasing one or more works. Works most appropriate for the Collection were identified and images of these were presented to the Advisory Committee for their opinion on which works the GAC should consider. The artist names are not known at this stage.

Following the Committee meeting, the GAC will let the BNC know which works from the selection they would still like to consider and will view the works at Liverpool John Moores University (as part of the Liverpool Biennial) in July 2018, with an Advisory Committee member if available, prior to the public opening of the exhibition.
