# Advisory Committee on the Government Art Collection

# Summary of the minutes of the meeting held on Wednesday 11 July 2018 at the Government Art Collection

# 4.3.3 Bloomberg New Contemporaries 2018

Following feedback from the Committee at the previous meeting on 15 March, the selected works were narrowed down. The Committee was advised that Bloomberg New Contemporaries (BNC) have now released the names of the artists and further information about their practice and the works in question, as well as prices. In advance of the BNC 2018 opening at the Liverpool School of Art & Design, Liverpool John Moores University, as part of Liverpool Biennial 2018 on 13 July, the shortlisted works were presented to the Committee one final time for consideration.

After discussion, the Committee agreed to acquire the following works:

MOHAMMED SAMI (born 1984) **Displacement** 2017 Acrylic on linen, 5.5 x 80.5 x 5 cm

MADELYNN MAE GREEN (born 1993) Summer '97 2018 Oil on canvas, 76 x 101 cm

This is the second year running that the GAC has allocated a budget for acquisition(s) from BNC. This exhibition provides a platform for the work of some of the most interesting artists graduating from UK art schools across the country. After Liverpool John Moores University, the exhibition will move to the South London Gallery with an opening there in November.
